~~A Bill for~~ **A Law to make provision for the Administration and Collection of Revenue due to the Government of Anambra State and Local Government Councils in Anambra State and to establish the relevant administrative structures and for matters connected thereto.**

BE IT ENACTED by the Anambra State House of Assembly as follows:-

*Citation and
Commencement.*

1. This Law may be cited as the Anambra State Revenue Administration Law, 2010 and shall come into force on the **2nd day of December, 2010.**

Interpretation.

2. In this Law, unless the context otherwise requires:-
 - “**authorized officer**” means any person employed in the State Internal Revenue Service or, for the time being, performing duties in relation to tax who has been specifically authorized by the Board or the Chairman to perform or carry out specific functions under this Law;
 - “**board**” means the Anambra State Board of Internal Revenue established under Section 3 of this Law;
 - “**book**” includes any register, document or other records of information and any account or accounting record however compiled, recorded or stored, whether in written or printed form or micro-film, digital, magnetic or electronic form or otherwise;
 - “**chairman**” means the Chairman of the Board appointed pursuant to Section 3 (1) (a) of this Law;
 - “**commissioner**” means the Commissioner charged with responsibility for matters relating to Finance;
 - “**consultants**” include accountants, legal practitioners or any other recognized professionals that have been certified by the Chartered Institute of Taxation of Nigeria, the Institute of Chartered Accountants of Nigeria or other relevant professional bodies in Nigeria, as the case may be;
 - “**document**” includes any record of information supporting accounts and accounting records, including reports or correspondence or memorandum or minutes of meetings, however compiled, recorded or stored, whether in written or printed form or micro-film, digital, magnetic, electronic or optical form or otherwise and all types of information stored on computers and any other similar equipments;
 - “**government**” means the Government of Anambra State and shall include a Local Government Council;
 - “**governor**” means the Governor of Anambra State;
 - “**member**” means a member of the Board appointed under Section 3 of this Law and includes the Chairman;
 - “**ministry**” means the Ministry charged with responsibility for matters relating to Finance;
 - “**officer**” means any person employed in the State Internal Revenue Service;
 - “**person**” includes a company or body corporate and any unincorporated body of persons;

“private dwelling” means any building or part of a building occupied as residential accommodation (including any garage, shed and other building used in connection therewith);

“state” means the Anambra State of Nigeria.

“tax” includes any duty, levy or revenue accruable to the Government in full or part under this Law, or any other enactment or law;

“taxable person” includes an individual or body of individuals, family, corporation sole, trustee or executor or a person who carries out in a place an economic activity, a person exploiting tangible property for the purpose of obtaining income therefrom by way of trade or business or person or agency of government acting in that capacity.

**Establishment
of the Board.**

3. (1) There is established a Board to be known as the Anambra State Board of Internal Revenue (referred to in this Law as “the Board”) whose operational arm shall be known as the Anambra State Internal Revenue Service (referred to in this Law as “the State Internal Revenue Service”)
- (2) The Board-
- (a) shall be a body corporate with perpetual succession and a common seal;
 - (b) may sue or be sued in its own name; and
 - (c) may acquire, hold and dispose of any property or interest in property, movable or immovable for the purpose of carrying out its functions under this Law.
- (3) The Board shall have such power and duties as are conferred on it by this Law or by any other Law.

**Appointment and
Composition of
Board.**

4. Members of the Board shall be appointed by the Governor and shall comprise of-
- (a) the Chairman who shall be-
 - (i) appointed from a relevant and recognized professional body;
 - (ii) a person knowledgeable and experienced in tax matters; and
 - (iii) the executive head of the State Internal Revenue Service;
 - (b) five Directors or Heads of Department who shall be appointed from the following Ministries on the recommendation of the Commissioner-
 - (i) Finance;
 - (ii) Economic Planning and Budget;
 - (iii) Lands, Survey and Town Planning;
 - (iv) Commerce and Industries; and
 - (v) Transport;
 - (c) two persons from the State Internal Revenue Service not below the rank of a Director;
 - (d) the Attorney-General of the State or his representative who shall be an officer not below the rank of a Director;
 - (e) three members from each of the three senatorial zones who shall be members of a relevant professional body and knowledgeable in tax matters to be nominated by the Governor on their personal merit; and
 - (f) the Secretary to the State Internal Revenue Service who shall also be the Secretary and an ex-officio member of the Board.

- Tenure and Remuneration of Members.** 5. (1) Members of the Board shall hold office for a period of 5 years in the first instance but may be reappointed for another term of 5 years and no more.
- (2) The Chairman and members of the Board excluding ex-officio members shall be paid such emoluments, allowances and benefits as the Governor may, from time to time, determine.
- Office of the Chairman.** 6. (1) The Chairman of the Board shall-
- (a) be the chief executive and accounting officer of the State Internal Revenue Service;
- (b) be responsible for the execution of the tax policies of Government and the day-to-day administration of the State Internal Revenue Service; and
- (c) hold office on such terms and conditions as may be specified in this Law and in his letter of appointment.
- Accountability** 7. (1) The Chairman as the Chief Executive and Accounting Officer of the State Internal Revenue Service, shall-
- (a) keep proper accounting records, in accordance with standard in accounting practice and financial regulations of the State, respect of:-
- (i) all revenues and expenditure of the State Internal Revenue Service;
- (ii) all its assets, liabilities and other financial transactions; and
- (iii) all other revenues collected by the State Internal Revenue Service, including income on investment;
- (b) prepare an annual report, including financial statements, in accordance with generally accepted accounting principles and practice; and
- (c) ensure that the available accounting records of the State Internal Revenue Service are adequate, in line with financial regulation and prepared by a qualified personnel, who must be a member of a recognized professional body.
- Secretary to the Board.** 8. The Secretary to the Board shall-
- (a) issue notices of meetings of the Board;
- (b) keep the records of the proceedings of the Board; and
- (c) carry out such duties as the Chairman or the Board may from time to time, direct.
- Meetings of the Board.** 9. (1) The Secretary shall summon a meeting of the Board whenever any business requiring the attention of the Board warrants same or whenever requested so to do by the Chairman or any three members.
- (2) Any five members of the Board, one of whom shall be the Chairman or a Director, shall constitute a quorum.
- (3) A majority decision of the members on any matter conveyed to the Secretary in written correspondences shall be treated in all respects as though it were a decision of the Board in an actual meeting unless any member has requested the submission of the matter to an actual meeting.

*Removal of
Members.*

10. Notwithstanding the provisions of Section 5 of this Law, the Chairman or a member of the Board shall cease to hold office if-
- (a) he resigns his appointment as member of the Board by notice under his hand addressed to the Governor; or
 - (b) he becomes of unsound mind; or
 - (c) he becomes incapable of carrying on the functions of his office either arising from infirmity of mind or of body; or
 - (d) he is convicted of a felony or of any offence involving dishonesty or corruption; or
 - (e) he becomes bankrupt or makes a compromise with his creditors; or
 - (f) the Governor is satisfied that it is not in the interest of the Board or of the public for the person to continue in office and the Governor removes him from office; or
 - (g) he has been found guilty of a breach of the Code of Conduct or other serious misconduct in relation to his duties; or
 - (h) in the case of a person possessing a professional qualification, he is disqualified or suspended from practicing his profession in any part of the world by an order of a competent authority; or
 - (i) in the case of a person who becomes a member by virtue of the office he occupies, he ceases to hold that office.

*Functions of
the Board.*

11. The Board shall be responsible for-
- (a) providing general policy guidelines regarding the functions of the State Internal Revenue Service and supervising the implementation of such policies;
 - (b) ensuring the effective and optimum collection of all revenue, including levies and penalties due to the State Government under the relevant Federal and State Laws;
 - (c) doing all such things that may be deemed necessary and expedient for the assessment and collection of all revenue;
 - (d) accounting for all amounts so collected in a manner to be prescribed by the Governor;
 - (e) making recommendations where appropriate to the Joint Tax Board on tax policy, tax reform, tax registration, tax treaties and exemption as may be required from time to time;
 - (f) appointing, promoting, transferring and imposing discipline on employees of the State Internal Revenue Service;
 - (g) making recommendations to the Governor regarding the terms and conditions of employment and the remuneration of staff of the State Internal Revenue Service;
 - (h) controlling the management of the State Internal Revenue Service on matters of policy, subject to the provisions of any regulations setting up the State Internal Revenue Service; and
 - (i) doing such other things as are in the opinion of the Board necessary to ensure the efficient performance of the functions of the State Internal Revenue Service under this Law.

*Powers of the
Board.*

12. (1) The Board shall be autonomous in the day-to-day running of the technical, professional and administrative affairs of the State Internal Revenue Service.

- (2) The Board may appoint such other persons to be employees of the State Internal Revenue Service in positions created by the Board and on such terms and conditions as shall be laid down by the Board subject to the provisions of this Law or any other enactment.
- (3) The Board may by notice in the Gazette of the State Government or in writing authorize any person within or outside Nigeria to-
 - (a) perform or exercise on behalf of the Board, any function, duty or power conferred on the Board; and
 - (b) receive any notice or other document to be given or delivered to or in consequence of this Law or any subsidiary legislation made under it.
- (4) Whenever the Board shall consider it necessary with respect to any revenue due to the State, the Board may acquire, hold and dispose of any property taken as security for or in satisfaction of the sum due or of any judgment debt due in respect of any revenue and shall account for any property and the proceeds of sale thereof in a manner to be prescribed by the Governor.
- (5) The Board may subject to such conditions as it may determine appoint and employ practicing tax practitioners or chartered accountants as monitoring agents to collect information through tax audit and to monitor compliance with relevant tax laws and except as it relates to Income Tax Assessment to do an act required to be done by it in the execution of its functions under this Law with the aim of achieving the internally generated revenue target of the State Government.
- (6) The Board may subject to prevailing conditions appoint and employ consultants, including tax consultants or accountants and agents to transact any business or to do any act required to be done in the execution of its functions or for carrying into effect the purpose of this Law.

Staff Regulation

13.

- (1) Subject to the provisions of this Law, the Board may make staff regulations relating generally to the conditions of service of the staff and, in particular such regulations may provide for-
 - (a) the appointment, promotion, termination, dismissal and disciplinary control of staff or employees of the State Internal Revenue Service; and
 - (b) appeals by staff or employees against dismissal or other Disciplinary measures, and until such regulations are made, any instrument relating to conditions of service in the public service of the State shall be applicable, with such modifications as may be necessary, to the employees of the State Internal Revenue Service.
- (2) The staff regulations made under subsection (1) of this section shall not have effect until approved by the Governor, and when so approved they shall be published in the State Gazette but the State Internal Revenue Service shall cause a notice of the staff regulations to be issued to all affected staff in such manner as the State Internal Revenue Service may, from time to time, determine.

- (3) If the Board thinks it expedient that any vacancy in the State Internal Revenue Service should be filled by a person holding office in the Civil Service of the State, it shall notify the Civil Service Commission to that effect and the Board may, by arrangement with the Commission, cause such vacancy to be filled by way of secondment or transfer.
- (4) Employment in the State Internal Revenue Service shall be subject to the provisions of such pension legislation for the time being in force in Anambra State and accordingly, officers and employees of the State Internal Revenue Service shall be entitled to pensions and other retirement benefits as are prescribed under the relevant law.
- (5) The terms and conditions of service including remuneration, allowances and benefits of the employees of the State Internal Revenue Service shall be determined by the Board subject to the approval of the Governor.

- (1) There shall be a Technical Committee of the Board (referred to in this Law as "the Technical Committee") which shall comprise of -
 - (a) the Chairman of the Board;
 - (b) two Directors appointed to the Board from within the State Internal Revenue Service;
 - (c) the Attorney-General or his representative not below the rank of a Director; and
 - (d) the Secretary of the State Internal Revenue Service who is also the Secretary of the Board.
- (2) The Technical Committee shall-
 - (a) have power to co-opt additional staff from within the State Internal Revenue Service and persons from the private sector who are experienced in revenue matters as the Technical Committee may consider necessary in the discharge of its duties;
 - (b) consider all matters that require professional and technical expertise and make recommendations to the Board;
 - (c) advise the Board on all its powers and duties specifically mentioned in sections 11 and 12 of this Law; and
 - (d) attend to such other matters as may from time to time be referred to it by the Board.

Fund of the
Board.

- 15. The Board shall establish and maintain a fund which shall consist of and to which shall be credited-
 - (a) an amount not less than 2.5% and not more than 10% of all revenue collected by the State Internal Revenue Service in the preceding year as may be appropriated by the State House of Assembly as administrative charge or cost of collection;
 - (b) all other monies which may, from time to time, accrue to the Board for other services including the disposal, lease or hire of or any other dealing with, any property vested in or acquired by the Board.
 - (c) all sums of money accruing to the Board or the State Internal Revenue Service by way of grants-in-aid, gifts, testamentary

disposition and endowments and contributions from any source whatsoever, and

- (d) such monies as may from time to time be granted to the Board by the State Government or donor agencies provided such grants are not intended for purposes contrary to the objects and functions of the Board.

Expenditure of the Board.

16. The Board shall defray from the fund established pursuant to Section 15 of this Law all the amounts payable under or in pursuance of this Law being sums representing-
- (a) any allowance or other payments due to the Chairman and other members of the Board;
 - (b) reimbursements to members of the Board or any committees set up by the Board for such expenses as may be expressly authorized by the Board or the State Internal Revenue Service;
 - (c) all remunerations, allowances or other costs of employment of the staff of the State Internal Revenue Service;
 - (d) pension and other retirement benefits payable under or pursuant to this Law or any other enactment;
 - (e) cost of acquisition and upkeep of premises belonging to or expenditure of the State Internal Revenue Service;
 - (f) investments, maintenance of utilities, staff promotion, training, research and similar activities;
 - (g) all other costs that may be necessary for the day to day operations of the State Internal Revenue Service; and
 - (h) any other payment for anything incidental to the foregoing provisions or in connection with or incidental to any other function of the State Internal Revenue Service.

Estimates.

17. The State Internal Revenue Service shall cause to be prepared, not later than the 30th day of September of each year, an estimate of its income and expenditure for the succeeding year.

Accounts and audits.

18. The State Internal Revenue Service shall cause proper accounts and records to be kept and such accounts shall, not later than six months after the end of each year, be audited by auditors appointed by the Board from the list and in accordance with the guidelines issued by the Auditor- General of Anambra State.

Annual Reports, etc.

19. (1) The State Internal Revenue Service shall not later than 30th of June in each year, submit to the Auditor-General of the State, a report its of activities during the immediate preceding year and shall include in such report the audited accounts of the internal revenue of the State.
- (2) The Auditor-General shall within 30 days of receipt of the report-
- (a) present a copy of the report to the State Executive Council; and
 - (b) present a copy of the report to the State House of Assembly.

Power to accept gifts

20. (1) The State Internal Revenue Service may accept gifts of land, money or other property on such terms and conditions, if any, as may be specified by the person or organization making the gift.

- (2) The State Internal Revenue Service shall not accept any gift if the conditions attached to it are inconsistent with its functions.
- Power to Borrow.** 21. The State Internal Revenue Service may, with the approval of the State House of Assembly, borrow by way of loan, overdraft or otherwise from any source such sums as it may require for the performance of its functions and meeting its obligations under this Law.
- Refunds to Taxpayers** 22. (1) After proper auditing, the State Internal Revenue Service shall refund to tax payers such overpayment of tax as is due.
- (2) The State Internal Revenue Service shall decide on who is eligible for refund, subject to such rules and conditions as may be approved by the Board.
- (3) The refund shall be made within ninety (90) days of the decision of the State Internal Revenue Service made pursuant to subsection (2) of this section, with the option of setting off the amount due against future tax.
- Powers and functions of the State Internal Revenue Service.** 23. The State Internal Revenue Service shall have power to-
- (a) assess all persons chargeable with tax in Anambra State;
 - (b) collect, recover and pay to the designated account any tax or levy due to the State Government under this or any other enactment;
 - (c) enforce payment of due taxes;
 - (d) in collaboration with the relevant ministries and agencies, review the tax regime and promote the application of tax revenues to stimulate economic activities and development;
 - (e) in collaboration with the relevant law enforcement agencies, carry out the examination and investigation of all cases of tax fraud or evasion with a view to determining compliance with the provision of this or any other relevant enactment;
 - (f) make, from time to time, a determination of the extent of financial loss and such other losses by government arising from tax fraud or evasion and such other losses (or revenue forgone) arising from tax waivers and other related matters;
 - (g) adopt measures to identify, trace, freeze, confiscate or seize the proceeds of tax fraud or evasion;
 - (h) adopt measures which include compliance enforcement and regulatory actions as well as introduction and maintenance of investigative and control techniques for the detection and prevention of non-compliance;
 - (i) collaborate with and facilitate exchange of scientific and technical information between it and relevant national or international agencies or bodies on tax matters;
 - (j) undertake exchange of personnel or other experts with complementary agencies for purposes of comparative experience and capacity building;
 - (k) establish and maintain a system for monitoring international dynamics of taxation in order to identify suspicious transactions and the persons involved;

- (l) provide and maintain access to up-to-date and adequate data and information on all taxable persons, individuals or corporations, for the purpose of efficient, effective and correct tax administration and to prevent tax evasion or fraud;
- (m) maintain database, statistics, records and reports on persons, organizations, proceeds, properties, documents or other items of assets relating to tax waivers, fraud or evasion;
- (n) undertake research and similar activities with a view to stimulating economic development and determining the extent and effects of tax fraud or evasion and make recommendations to the government on appropriate intervention and preventive measures;
- (o) collate and keep under review all policies of the State Government relating to taxation and revenue generation and undertake a systematic and progressive implementation of such policies;
- (p) maintain a liaison with the office of the Attorney- General of the State, all government, security and law enforcement agencies and such other financial supervisory institutions in the enforcement and eradication of tax related offences;
- (q) issue taxpayer identification number to every person taxable in Anambra State;
- (r) from time to time specify the form of returns, claims, statements and notices necessary for the due administration of the powers conferred on it by this Law or any other enactment;
- (s) carry out and sustain public awareness and enlightenment campaigns on the benefits of tax compliance within the State; and
- (t) carry out such other activities as are necessary or expedient for the full discharge of all or any of the functions prescribed under this Law.

Establishment of the Local Government Revenue Committee 24.

- (1) There is established for each Local Government Area of the State a Committee to be known as Local Government Revenue Committee (referred to in this Law as the Local Government Revenue Committee).
- (2) The Local Government Revenue Committee shall comprise of the following-
 - (a) a person to be appointed by the Local Government Chairman or where there is no Local Government Council Legislature in place, by the head of the Local Government by whatever name called, not being a political appointee or public officer from within the Local Government Council and who shall be experienced in revenue matters and shall be the Chairman;
 - (b) three heads of department of the Local Government Council including Treasury Department; and
 - (c) a member of the public not being a member of the Council who is experienced in revenue matters to be nominated by the legislative arm of the Council or by the head of the Local Government where there is no legislative arm of the Local Government Council.

*Functions of

(3) All appointments made pursuant to this Section shall be subject to the approval of the Legislative Arm of the Council and where not in existence, the Commissioner of the Government responsible Local for Government affairs.

25.

(1) The Local Government Revenue Committee shall be responsible for the assessment and collection of all taxes fines, rates, charges or other revenue under its jurisdiction and shall account for all amounts so collected in a manner to be prescribed by the Chairman or head of the Local Government, subject to the financial memorandum and guidelines on Local Government Administration.

(2) The Local Government Revenue Committee shall be autonomous of the Local Government Treasury and shall be responsible for the day-to-day administration of the Department or personnel which forms its operational arm.

*Establishment
and Composition
of Joint State
Revenue Committee.*

26. There is established for Anambra State a Joint State Revenue Committee which shall comprise of-

- (a) the Chairman of the State Internal Revenue Service as the Chairman;
- (b) the Chairman of each Local Government Revenue Committee in the State;
- (c) a representative of the State Ministry responsible for Local Government affairs not below the rank of a Director;
- (d) the Legal Adviser of the State Internal Revenue Service; and
- (e) the Secretary of the Committee, who shall be a staff of the State Internal Revenue Service.

*Functions of
Joint State
Revenue Committee.*

27. The functions of the State Joint Revenue Committee shall be to-

- (a) harmonize tax administration in the State;
- (b) deal with revenue matters of common concern to the State and Local Government authorities;
- (c) enlighten members of the public generally on State and Local Government revenue matters;
- (d) consider relevant resolutions of the Joint Tax Board for implementation in Anambra State; and
- (e) advise the Joint Tax Board and the State and Local Governments on revenue matters.

*Designation
of Magistrates
to adjudicate on
Revenue Matters.*

28. The Chief Judge of the State shall designate in each Local Government Area at least two Magistrates (save where the number of Magistrates in a Local Government Area is not up to two) who shall give priority to matters affecting the revenue of the State and of the relevant Local Government Council.

*Definition of
Revenue Collector*

29. (1) For the purpose of this Law, a Revenue Collector means a duly authorized officer of the State Internal Revenue Service or of a Local Government Revenue Committee.

(2) The production by a Revenue Collector of an identity card and certificate or warrant issued by and having printed thereon the office of the relevant revenue authority setting out his full names, and stating

that he is authorized to exercise the functions of a Revenue Collector, shall be sufficient evidence that the Revenue Collector is duly authorized for the purpose of this Law.

Mode of payment 30. Except as otherwise provided in any Law, revenue due to any authority in Anambra State shall be payable by cash, bank draft, electronic debit or credit card, or money transfer into any of the banks designated by the Board or the Chairman or head of the relevant Local Government Council entitled to receive such revenues.

Revision of Assessment 31. (1) If any person disputes an assessment he may apply to the Board, by notice of objection in writing, to review and to revise the assessment, and such application shall state precisely the grounds of objection to the assessment and shall be made within thirty days from the date of service of the notice of the assessment.

 (2) On receipt of a notice of objection, the Board may require the person giving the notice to furnish such particulars and to produce such books or other documents as the Board may deem necessary, and may summon any person who may be able to give information which is material to the determination of the objection to attend for examination by an officer of the appropriate Division on oath or otherwise.

 (3) In the event of any person who has objected to an assessment agreeing with the Board as to the correct amount of the tax chargeable, the assessment shall be amended accordingly and notice of the tax chargeable shall be served to such person.

Provided that if an applicant for revision under the provisions of this section fails to agree with the Board the amount of the tax chargeable, the Board shall give notice of refusal to amend the assessment as desired by such person and may revise the assessment to such amount as the Board may, according to the best of its judgment, determine and give notice of the revised assessment and of the tax payable together with notice of refusal to amend the revised assessment and, wherever requisite, any assessment shall be treated as a reference to an assessment or to an additional assessment as revised under the provisions of this proviso.

Errors and Defects in Assessment and Notice. 32. No assessment, warrant, notice or other proceeding made in accordance with the provisions of this Law or any other revenue law in force in the State shall be quashed or deemed to be void or voidable by want of form, mistake, defect or omission if the same is in substance in conformity with this Law or other applicable law and if the person charged or intended to be charged or affected by it is to common intent and understanding designated therefrom.

Administration of tax laws. 33. (1) The State Internal Revenue Service shall have power to administer any law on taxation which the State House of Assembly or the National Assembly may confer power on it to administer.

 (2) The State Internal Revenue Service may, with the approval of the Governor by instrument published in the State Gazette, appoint any ministry, department or agency to collect revenue pursuant to its powers under subsection (1) of this section.

- (1) For the purpose of obtaining full information in respect of the profits or income of any person, body corporate or organization, the State Internal Revenue Service may give notice to that person, body, corporate or organization requiring him or it, within the time specified by the notice to-
 - (a) complete and deliver to the State Internal Revenue Service any return specified in such notice;
 - (b) appear personally before an officer of the State Internal Revenue Service for examination with respect to any matter relating to such profits or income;
 - (c) produce or cause to be produced for examination, books, documents and any other information at the place and time stated in the notice, which may be from day-to-day, for such period as the State Internal Revenue Service may deem necessary; or
 - (d) give orally or in writing any other information including name and address specified in such notice.
- (2) For the purpose of paragraphs (a) to (d) of subsection (1) of this Section, the time specified by such notice shall not be less than seven (7) days from date of service of such notice except that an officer of the State Internal Revenue Service not below the rank of a Chief Inspector of Taxes or its equivalent may act in any of the cases stipulated in paragraphs (a) to (d) of subsection (1), without giving any of the required notices set out in this section.
- (3) a person who contravenes the provisions of this section is, in respect of each offence, liable on conviction to a fine equivalent to 100 percent of his actual tax liability.
- (4) The provision of this section or any other provision of this Law shall not be construed as precluding the State Internal Revenue Service from verifying by tax audit or investigating any matter relating to any returns or entries in any book, document or accounts, including those stored on a computer, or digital or magnetic or optical or electronic media as may, from time to time, be specified by the State Internal Revenue Service.
- (5) Any person may apply in writing to the Board for an extension of time within which to comply with the provisions of this Section and Section 35 of this Law, provided that the person-

(1) The State Internal Revenue Service may give notice in writing to any person it considers necessary requiring such person to deliver within a reasonable time specified in such notice fuller or further returns in respect of any matter relating to the functions of the State Internal Revenue Service under this Law.
- (2) Where tax is not paid when it falls due under any enactment by any person from whom it is due, whether or not the payment of that tax has been secured by a bond or otherwise, it shall be paid on demand made by the State Internal Revenue Service either on that person personally or by delivering the demand in writing to his place of abode or business, and if it is not paid on demand, the person in default shall, in addition to the amount of tax due and payable, also be liable to a fine equal to the amount of tax due and payable.

36. (1) Without prejudice to Section 34 of this Law, every person engaged in banking shall on demand prepare and deliver to the State Internal Revenue Service, quarterly returns specifying-
- (a) in the case of an individual, all transactions involving the sum of one million Naira and above; or
 - (b) in the case of partnerships or unincorporated business names, all transactions involving the sum of three million Naira and above; and
 - (c) the names and addresses of all customers of the bank connected with the transaction.
- (2) Subject to subsection (1) of this section, for the purpose of obtaining information relating to taxation, the State Internal Revenue Service may give notice to any person including a person engaged in banking business in Nigeria to provide within the time stipulated in the notice, information including the name and address of any person specified in the notice;

- (ii) no such tax or levy is due on the person or on his income or property;
 - (iii) the person is not liable to tax for any of those 3 years;
- (b) the person is liable to produce evidence that he paid withholding tax by deduction at source and that the assessment year to which the tax relates falls within the period covered by the tax clearance, and that he has fully paid any balance of the tax after credit has been given for the tax so deducted.
- (2) Payment of income tax for the current year shall not be made a condition for the issuance of the certificate unless the applicant is leaving the State finally.
- (3) The tax clearance certificate may be issued in paper form or stored in an electronic format on a machine- readable smart card (referred to as Electronic Tax Clearance Certificate) which holds tax information peculiar to the particular applicant and which shall be presented for checking by the holder whenever his tax compliance status is required.
- (4) Where a person who has applied for a tax clearance certificate has discharged his own tax liability but has failed to remit withholding tax or pay as you earn (PAYE) deductions collected by him on behalf of the State Government, no tax clearance certificate may be issued to that person.
- (5) The Board may decline to issue a tax clearance certificate and in that event it shall within two weeks of receipt of the application give reason for the denial.
- (6) (a) A Ministry, Department, Agency or Official of the State Government; or of any Local Government Council; or any corporate body, statutory authority or person empowered in that regard by this or any other law shall demand tax clearance certificate for the three years immediately preceding the current year of assessment as precondition to transacting any business, including but not limited to the following-
- (i) application for Governor's consent to real property transactions;
 - (ii) application for certificate of occupancy or temporary occupation license;
 - (iii) application for registration as a contractor;
 - (iv) application for award of contracts by government, its agencies and registered companies;
 - (v) application for approval of building plans;

- (7) A Tax Clearance Certificate must contain the following information relating to each of the 3 years immediately preceding the current year of assessment-
- (a) chargeable income of holder;
 - (b) tax payable;
 - (c) tax paid; and
 - (d) tax outstanding.

And where no tax is due from the holder or on his income or property the certificate shall contain a statement to that effect.

- (8) The Board shall be the sole authority to issue Tax Clearance Certificate under this Law, but it may exercise its powers by employing the services of any person or company, provided that:

- (c) the Board shall make available to the taxpayer at cost to the taxpayer to be determined by the Board a smart card with the taxpayer's identity number, names, signature and photograph embossed on the front side;

 - (e) the data shall be made accessible to third parties only in a form which permits identification of the taxpayer and access to information on him for no longer than is necessary for the purposes of verifying his tax clearance status;

- (3) Where the State Internal Revenue Service is able to obtain, in place of taking physical possession of such equipment, computer or storage media under subsection (2) of this section and the State Internal Revenue Service possesses the ability, equipment and computer software to make exact duplicate copies of all information stored on the computer hard drive and preserve all the information exactly as it is on the original computer, the State Internal Revenue Service shall make such a copy and use it as digital evidence during such investigation or criminal proceedings.
- (4) The occupier of a land or building or place that is entered or proposed to be entered by an authorized officer, shall-
 - (a) provide the officer with all reasonable facilities and assistance for the effective exercise of powers conferred by this Law; and
 - (b) answer questions relating to the effective exercise of the powers, orally, or if required by the officer, in writing or by statutory declaration.
- (5) Notwithstanding subsection (1) of this section, the authorized officer or a person accompanying the officer, shall not enter any private dwelling except with the consent of an occupier or pursuant to an authorization issued under subsection (6) of this section.

(c) An addition imposed under this section shall not be deemed to be part of the tax paid for the purpose of claiming relief under any of the provisions of this Law.

(2) Any person who without lawful justification or excuse, (the proof of which shall lie on the person), fails to pay any tax imposed within the prescribed period commits an offence under this Law.

(3) The Board shall have the power to remit part or the whole of the addition due under subsection (1) of this section.

Power to Distrain

42.

(1) Notwithstanding the power conferred on the relevant revenue authority for the enforcement of payment of revenue, if payment has become due and a demand note has, in accordance with the provisions of the relevant Law, been served on the chargeable person or his agent, and payment is not made within the time limited by the demand note, the State Internal Revenue Service or other relevant revenue authority may for the purpose of enforcing payment of the amount due, distraint-

- (a) upon the goods, chattels or other properties movable or immovable, of the person liable to pay the tax outstanding; and
- (b) upon all machinery, plant, tools, vehicles, animals and effects in the possession, use or found on the premises or on the land of the person.

(2) The authority to distraint under this section shall be in such form as the relevant revenue authority may direct and that authority shall be sufficient warrant and authority to levy by distress the amount of revenue due.

(3) For the purpose of levying any distress under this section, an officer duly authorized by the Chairman may apply to a Judge of the State High Court sitting in Chambers under oath for the issue of a warrant under this section.

(4) A Judge of the High Court sitting in Chambers may authorize such officer referred to in subsection (3) of this section, in writing, to execute any warrant of distress and, if necessary, break open any building or place in the daytime for the purpose of levying such distress and he may call to his assistance any police officer and it shall be the duty of any police officer when so required to aid and assist in the execution of any warrant of distress and in levying the distress.

(5) Things distrained under this section may, at the expense of the defaulter, be kept for fourteen days and if at the end of this period, the amount due in respect of the revenue and cost and charges of, and incidental to the distress are not paid, they may, subject to sub-section (6) of this section, be sold at any time.

(6) Out of the proceeds of a sale under this section, the cost of charges for and incidental to the sale and of keeping the distress and the disposal thereunder, shall be paid. Thereafter the amount of revenue due shall

be paid and the balance (if any) shall be payable to the defaulter on demand being made by him or on his behalf within three months of the date of the sale or it shall be forfeited.

- (7) Nothing in this section shall be construed as to authorize the sale of an immovable property without an order of a High Court made upon application in such form as may be prescribed by the rules of court or by the Sherrifs and Civil Process (Judgment Enforcement) Rules.
- (8) In exercise of the powers of distress conferred by this section, the person to whom the authority is granted under subsection (4) of this Section may distrain upon all goods, chattels and effects this belonging to the debtor wherever the same may be found in Nigeria.

Recovery of tax.

43.

- (1) Notwithstanding the provisions of this Law or of any other relevant laws, any amount due by way of tax shall constitute a debt due to the State and may be recovered by a civil action brought by the Board.
- (2) Where any tax has been short levied or erroneously repaid, the person who should have paid the amount short levied or to whom the repayment has erroneously been made shall on demand by the proper officer, pay the amount short levied or erroneously repaid, as the case may be, and any such amount may be recovered as if it were tax to which a person to whom the amount was so short levied or erroneously repaid were liable.

Tax Investigations.

44.

- (1) The State Internal Revenue Service shall take all necessary measures to assist any relevant law enforcement agency in the investigation of any offence under this Law.
- (2) The State Internal Revenue Service shall have the power to investigate or cause investigation to be conducted to ascertain the violation of any tax law, whether or not such violation has been reported to the State Internal Revenue Service.
- (3) In conducting any investigation under subsection (2) of this Section, the State Internal Revenue Service may cause investigation to be conducted into the properties of any person if it appears to the State Internal Revenue Service that the lifestyle of the person and extent of his properties are not justified by his declared source of income.
- (4) Where any investigation under this section reveals the commission of any offence or an attempt to commit any offence, the State Internal Revenue Service shall submit its findings to the relevant law enforcement agency and the Attorney-General of the State for purposes of further investigation or prosecution.

45.

- (1) The State Internal Revenue Service may co-opt the assistance and co-operation of law enforcement agencies in the discharge of its duties under this Law.

Power to enter, Inspect and Seize

46. (1) Any tax officer armed with the warrant issued by a Judge of the State High Court and accompanied by a number of law enforcement officers as shall be determined by the Chairman may-
- (a) enter any premises covered by such warrant and search for, seize and take possession of any book, document or other article used or suspected to have been used in the commission of an offence;
 - (b) inspect, make copies of, or take extracts including digital copies from any book, record, document or computer, regardless of the medium used for their storage or maintenance;
 - (c) search any person who is in or on such premises;
 - (d) open, examine and search any article, container or receptacle;
 - (e) open any outer or inner door or window of any premises and enter same or otherwise forcibly enter the premises; and
 - (f) remove by reasonable force any obstruction to such entry, search, seizure or removal as he is empowered to effect.
- (2) No person shall be bodily searched under this section except by a person of the same gender.

Power to pay reward.

47. (1) The State Internal Revenue Service may, with the approval of the Board, reward any person, not employed in the State Internal Revenue Service, in respect of any information that may be of assistance to the State Internal Revenue Service in the performance of its duties under this Law upon meeting such conditions as may be determined by the Board and the amount of such reward shall also be at the discretion of the Board.
- (2) The identity of the person who gives such information as referred to in subsection (1) above to the State Internal Revenue Service shall be kept confidential and any current or former member of the State Internal Revenue Service or Board that discloses the identity of such person shall be dealt with in accordance with the provisions of Section 49 of this Law with regard to confidential information.

Immunity from Action.

48. An officer of the State Internal Revenue Service or of any other tax authority in the State shall not be liable in any civil action or proceeding for any act or omission done by him in the performance of his duties or exercise of the powers conferred upon him under this or any other Law.

Information and documents to be confidential.

49. (1) All information and documents supplied or produced in pursuance of any requirement of this Law or any other legislation being implemented by the State Internal Revenue Service shall be treated as confidential.
- (2) Except as otherwise provided under this Law or as otherwise authorized by the Governor or Chairman, any member or former member of the Board or any employee or former employee of the State Internal Revenue Service who communicates or attempts to communicate any confidential information or the content of any such document to any person commits an offence and shall be liable on conviction to a fine of one hundred thousand Naira (N100,000.00) or to imprisonment for two (2) years or both.

Establishment of Tax Appeal Commissioners.

50. The Governor may, by Notice in the State Gazette, establish a Body of Tax Appeal Commissioners.


51. (1) The Body of Tax Appeal Commissioners shall consist of a Chairman and five other members none of whom shall be a public officer.
- (2) A Tax Appeal Commissioner-
- (a) shall be appointed by the Governor, by Notice in the State Gazette, from among persons appearing to him to have had experience and shown capacity in the management of a substantial trade or business or the exercise of a profession of law, accountancy or taxation in the State;
 - (b) subject to the provisions of this Section, shall hold office for a period of three years from the date of appointment;
 - (c) may at any time resign his appointment by notice in writing addressed to the Governor, except that on the request of the Governor he may continue to act as a Tax Appeal Commissioner after the date of his resignation and sit at any further hearing in a case in which he has already sat before the date to hear an appeal until a final decision has been given with respect to that appeal;
 - (d) shall cease to be a Tax Appeal Commissioner if the Governor determines that his office be vacant and upon notice of the determination being published in the State Gazette or on his acceptance of a political or public office appointment.
- (3) The Governor shall designate a public officer to be the Secretary to the body of Tax Appeal Commissioners (referred to in this Law as the Secretary) and the name and official address of the Secretary shall be published in the State Gazette.
- (4) Subject to the provisions of this Section, the Body of Tax Appeal Commissioners shall remain in office until a new body is sworn in.

A taxable person being aggrieved by an assessment to income tax made upon him, having failed to agree with the Board in the manner provided in Section 57(3) of the Personal Income Tax Act (Cap P8 LFN 2004), may appeal against the assessment upon giving notice as provided in Section 53 of this Law within thirty days after the date of service of notice of the refusal of the Board to amend the assessment as desired.

Notice of

53. (1) A notice of appeal to be given under the provisions of this Section shall be given in writing to the Board and shall set out the following-

- (2) As soon as he may after receipt of the notice of appeal, the Secretary shall having regard to the grounds of appeal therein disclosed and to any relevant provisions of this Law, deliver a copy of the notice to the Board and the appeal shall be listed by the Secretary for hearing accordingly.
- (3) A notice or other document to be given to the Tax Appeal Commissioners shall be addressed to the Secretary and be delivered at or sent by registered post to his official address
- (4) A taxpayer may discontinue an appeal by him under this Section upon giving notice to the Secretary in writing at any time before the hearing of the Appeal.

- (1) The Tax Appeal Commissioners shall, as often as may be necessary, meet to hear appeals in any town where an office of the Board is situated and, subject to the provisions of subsection(2) of this Section at any such meeting-
 - (a) any three or more Tax Appeal Commissioners may hear and decide an appeal; and
 - (b) the Tax Appeal Commissioners present shall elect one of their number to be the Chairman for the meeting .
- (2) A Tax Appeal Commissioner who has a direct or indirect financial interest in a taxpayer or being a relative of a person having such an interest, and having knowledge thereof, shall, when any appeal by such taxpayer is pending before the Body of Tax Appeal Commissioners, declare such interest to the other Tax Appeal Commissioners and give notice to the Board in writing of such interest or relationship, and shall not sit at any meeting for the hearing of that appeal.
- (3) The provisions of subsection (2) of this Section shall also apply where a Tax Appeal Commissioner is a legal practitioner or an accountant, and the taxpayer is or has been a client of that Tax Appeal Commissioner.
- (4) The Secretary shall give seven clear working days notice to the Board and to the appellant of the date and place fixed for the hearing of an appeal except in respect of an adjourned hearing for which the Tax Appeal Commissioners have fixed a date at their hearing.
- (5) All notices, precepts and documents, other than decisions of the Tax Appeal Commissioners, may be signed under the hand of the Secretary.

- (6) All appeals before the Tax Appeal Commissioners shall be heard in camera.
- (7) A taxpayer who appeals against an assessment shall be entitled to be represented at the hearing of the appeal. If the person intended by the taxpayer to be his representative in an appeal is unable for good cause to attend the hearing, the Tax Appeal Commissioners may adjourn the hearing for such reasonable time as they think fit, or admit the appeal to be made by some other person or by way of written statement.
- (8) The onus of proving that the assessment complained of is excessive shall be on the appellant.
- (9) At the hearing of an appeal, if the representative of the Board proves to the satisfaction of the Tax Appeal Commissioners or the court hearing the appeal in the first instance that -

 - (b) the appeal is frivolous or vexatious or is an abuse of the appeal process; or
 - (c) it is expedient to require the appellant to pay an amount as security for processing the appeal, the Tax Appeal Commissioners or, as the case may be, the court may adjourn the hearing of the appeal to any subsequent day and order the appellant to deposit with the Board before the day of the adjourned hearing an amount, on account of the tax charged by the assessment under appeal, equal to the tax charged on the appellant for the preceding year of assessment under appeal, whichever is the lesser.
- (10) If the appellant fails to comply with an order under subsection (9) of this Section, the assessment against which he appealed shall be confirmed and the appellant shall have no further right of appeal whatsoever with respect to that assessment.
- (11) The Tax Appeal Commissioners may confirm, reduce, increase or annul the assessment or make such order thereon as they see fit.

58. Any person obliged to deduct any tax under this Law or any other applicable law, who fails to deduct or having deducted fails to pay to the State Internal Revenue Service within thirty days from the date the amount was deducted or the time the duty to deduct arose, shall be guilty of an offence and shall be liable to pay the tax withheld or not remitted in addition to a penalty of 10 percent of the tax withheld or not remitted per annum and interest at the prevailing commercial rate.

Impersonating a Revenue Collector.

66. (1) Any person who not being a Revenue Collector holds himself out as a Revenue Collector and attempts to collect or collects any revenue due to the State or a Local Government Council shall be guilty of an offence and be liable on conviction to a fine of two hundred and fifty thousand Naira (N250,000.00) or imprisonment for three (3) years or both and any amount collected by him shall be forfeited to the State Government or Local Government Authority, as the case may be.
- (2) If for the purpose of obtaining admission to any building or other place of doing or procuring to be done any act which he would not be entitled to do or procure to be done of his own authority, or for any other unlawful purposes, any person, not being an authorized officer, assumes the name or designation or impersonates the character of an authorized officer, he shall, in addition to any other punishment to which he may be liable, be liable on conviction to a fine of one hundred thousand Naira (N100,000.00) or to imprisonment for a term of two (2) years.

Prosecution.

67. (1) Any criminal proceedings for an offence under this Law shall be instituted by or with the consent of the Attorney-General of the State.

Power to compound offences.

68. (1) The State Internal Revenue Service may, with the approval of the Attorney-General of the State compound any offence under this Law by accepting a sum of money not exceeding the maximum fine specified for the offence.
- (2) The State Internal Revenue Service shall issue a treasury receipt for any money received under subsection (1) of this Section.

Penalty.

69. (1) Any person who contravenes any provisions of this Law for which no specific penalty is provided, commits an offence and shall be liable on conviction to a fine of fifty thousand Naira (N50,000.00) or imprisonment for a term not exceeding six months or both.
- (2) Where an offence under this Law is committed by a body corporate or firm or other association of individuals-

- (2) Any action taken under subsection (1) of this section shall be subject to the approval of the Board and when such approval is obtained the Chairman shall notify the person surcharged under this section.
- (3) The Board may at any time withdraw any surcharge in respect of which a satisfactory explanation has been received from the person concerned or if it otherwise appears that no surcharge should have been made, the Board shall at once inform the person concerned of such withdrawal.

suits against

75. (1) Subject to the provisions of this Law, the provisions of the Public Officers Protection Act and the State Proceedings Law apply in relation to any suit instituted against any member, officer or employee of the State Internal Revenue Service.

- (2) No suit against the Chairman or a member of the Board or any employee of the State Internal Revenue Service for any act done in pursuance or execution of this Law or any other law or enactment or of any public, duty or authority or in respect of any alleged neglect or default in the execution of this Law or any other law or enactment, duty or authority, shall lie or be instituted in any court unless it is commenced-
 - (a) within three months after the act, neglect or default complained of; or
 - (b) in the case of a continuation of damage or injury, within six months next after the ceasing thereof.
- (3) No suit shall be commenced against the Chairman or a member of the Board or any officer or employee of the State Internal Revenue Service before the expiration of a period of one month after written notice of the intention to commence the suit shall have been served on the State Internal Revenue Service by the intending plaintiff or his agent.
- (4) The notice referred to in subsection (3) of this section shall clearly and explicitly state-
 - (a) the cause of action;
 - (b) the particulars of the claim;
 - (c) the name and place of abode of the intending plaintiff; and
 - (d) the relief which he claims;and shall be filed in the registry of the High Court of the State and served through the Court.

Service of Documents.

76. A notice, summons or other document required or authorized to be served on the State Internal Revenue Service under the provisions of this Law or any other law may be served by delivering it to the Chairman or by sending it by registered post-addressed to the Chairman at the principal office of the State Internal Revenue Service.

Restriction on execution against property of the State Internal Revenue Service.

77. (1) In any action or suit against the State Internal Revenue Service, no execution or attachment of process in the nature thereof shall be issued against the State Internal Revenue Service unless not less than three months notice of the intention to execute or attach has been given to the State Internal Revenue Service.
- (2) Any sum of money which by the judgment of any court has been awarded against the State Internal Revenue Service shall, subject to any direction given by the court, where no notice of appeal against the judgment has been given, be paid from the fund of the State Internal Revenue Service.

Indemnity

78. A member of the Board, the Chairman or any officer or employee of the State Internal Revenue Service shall be indemnified out of the assets of the State Internal Revenue Service against any liability incurred by him in defending any proceeding, whether civil or criminal, if the proceeding is brought against him in his capacity as a Chairman or member of the Board or officer or other employee of the State Internal Revenue Service.

Directives by the Governor, etc.

79. The Governor may give to the State Internal Revenue Service or the Chairman such directives of a general nature or relating generally to matters of policy with regards to the exercise of its or his functions as he may consider necessary and it shall be the duty of the State Internal Revenue Service or the Chairman to comply with the directives or cause them to be complied with.

Power to make Regulations.

80. The Board may with the approval of the Governor, make regulations for carrying into effect the provisions of this Law and for the due administration of its provisions and may in particular make regulations-
- (a) prescribing the forms for returns and other information required under this Law or any other law;
 - (b) prescribing the procedure for obtaining any information required under this Law or any other law; and
 - (c) for any other incidental matters.

Saving and Transitional Provisions relating to Staff or Employees.

81. (1) Notwithstanding anything to the contrary in this Law, any director, employee, staff or officer who immediately before the commencement of this Law held office in the State relating to Board of Internal Revenue (including its operational arm) referred to in this Law as "the former Board" existing immediately before the commencement of this Law and who has been made an offer of employment by the State Internal Revenue Service shall be deemed to have been transferred to the State Internal Revenue Service established under this Law on terms and conditions not less favourable than those obtaining immediately before the commencement of this Law and service or employment in the former Board shall be deemed to be service or employment in the State Internal Revenue Service established under this Law for purposes of pension.
- (2) Every director, employee, staff or officer transferred into the State Internal Revenue Service by virtue of subsection (1) of this section shall notify the State Internal Revenue Service established under this Law in writing within sixty (60) days after the commencement of this Law or after he receives an offer of appointment from the new Board (which ever is later) of his acceptance or refusal and any director, employee, staff or officer who fails to so notify the State Internal Revenue Service shall be deemed to have rejected the offer
- (3) Any director, employee, staff or officer referred to in subsection (2) is deemed to be an employee of the State Internal Revenue Service established under this Law, beginning on the day that this Law comes into force and ending on the expiry of the period of grace under subsection (2) or on the day of his written refusal and the State Internal Revenue Service established under this Law is deemed to be his employer for all purposes during that period.
- (4) An employee who is not transferred or who refuses or is deemed to have refused the transfer or a job offer made by the Board established under this Law, as specified in subsection (1) of this section, shall be transferred to the Office of the Head of the Civil Service of the State for redeployment in the Civil Service immediately after the time specified in subsection (2) of this section.

Existing Properties and Assets.

82. (1) There shall be vested in the Board all assets, funds, resources and other immovable property which immediately before the commencement of this Law were vested in the former Board existing immediately before the commencement of this Law.
- (2) All rights, interests, obligations and liabilities of the former Board existing immediately before the commencement of this Law under any contract or

instrument, or in law or in equity apart from any contract or instrument, shall by virtue of this Law be assigned to and vested in the new Board.

- (3) Any contract or instrument referred to in subsection (2) of this section shall be of the same force and effect as if entered into by the Board or the State Internal Revenue Service established under this Law and shall be enforceable as if the Board established under this Law had been named therein or had been a party thereto.
- (4) The Board shall be subject to all obligations and liabilities to which the former Board existing immediately before the commencement of this Law had and all other persons shall as from the commencement of this Law have the same rights, powers and remedies against the Board as they had against the former Board.
- (5) Any proceeding pending or existing immediately before the commencement of this Law against the former Board in respect of any rights, interests, obligations or liability of the former Board may be continued, or be commenced and the determination of a court of law, tribunal or other authority or person may be enforced by or against the Board or the State Internal Revenue Service.
- (6) Any regulations, orders, bye-laws or notices made or issued or deemed to be made or issued by or for the purposes of the former Board existing immediately before the commencement of this Law shall be deemed to have been made or issued by or for the purposes of the Board and shall continue in force until revoked or amended; subject to such modifications as may be applicable to the Board established under this Law.

Continuation of appointments and contracts made by Government.

83. As from the commencement of this Law all contracts entered into and all appointments of consultants and agents made by the Government or by any other person on its behalf to transact any business or to do any act required to be done by the Board or the State Internal Revenue Service in the execution of their functions under this Law or for carrying into effect the purposes of this Law, shall be deemed to have been made by the Board or the State Internal Revenue Service and shall be taken over and executed by the Board or by the State Internal Revenue Service as if made by the Board or by the State Internal Revenue Service established under this Law.

Continuation and completion of disciplinary proceedings.

84. (1) As from the commencement of this Law, any disciplinary proceeding pending or existing against any employee of the former Board who has opted into the service of the Board established under this Law, shall be continued and completed by the Board
- (2) An appeal or grievance already filed, but which has not been finally disposed of on the coming into force of this Law shall be dealt with and disposed of in accordance with the Civil Service Rules as if this Law had not come into force.

Transfer of Rights and Obligations.

85. (1) The administration and control of all rights, obligations and liabilities that were under the administration and control of the former Board are hereby transferred to the Board established under this Law.
- (2) The administration of any real property that were immediately before the coming into force of this Law under the administration or administrative

responsibility of the former Board or its agencies or bodies for the purposes of that former Board are hereby transferred to the Board established under this Law.

- (3) All orders, rules, regulations, decisions, directions, licences, authorizations, certificates, consents, approvals, declarations, designations, permits, resignations, rates or other documents that are in force before the coming into force of this Law and that are made or issued by the Governor, Chairman of the former Board or any person under their control shall continue in force as if they were made, or issued by the Governor, the Board established under this Law, the Chairman or an employee of the State Internal Revenue Service as the case may be, until they expire or are repealed, replaced, reassembled or altered.
- (4) Every reference to the Governor, former Board, Chairman or any person under their control in a document issued in the name of the Governor, former Board, Chairman or employee of the former Board is to be read, unless the context otherwise requires, as a reference to the Governor, Board, Chairman, or an employee of the Board established under this Law, as the case may be.
- (5) Every affidavit sworn to or document duly certified by an officer of the former Inland Revenue Service before the day on which this section comes into force has the same probative value as if it were sworn to or certified by an employee of the State Internal Revenue Service on or after that day.

Relevance
of other laws
P.I.T.A
Cap P8 LFN 2004.

86. (1) Notwithstanding the provisions of this Law, the relevant provisions of all laws to be administered by the State Internal Revenue Service shall be read with such modifications as to bring them into conformity with the provisions of the Personal Income Tax Act, 1993.
- (2) If the provisions of any other State Law for the charging and collection of revenue are inconsistent with the provisions of this Law, the provisions of this Law shall prevail and the provisions of that other law shall to the extent of its inconsistency be void.

Amendment of
Cap 47 Laws of
Anambra State 1991.

87. (1) Section 2 of the Finance Law Cap 47 Laws of Anambra State is amended by deleting the definition of "Board" and inserting the following new definition-
 - (1) "Board" means the Anambra State Board of Internal Revenue established under Section 3 of the Anambra State Revenue Administration Law.
 - (2) Sections 16, 17 and 18 of the Anambra State Finance Law are hereby deleted.

EXPLANATORY NOTE

(This note does not form part of this Law but it is intended to explain it). The purpose of this Law is to make provision for the Administration and Collection of various revenue flows in the State and Local Government Councils and to establish relevant administrative structures and for connected purposes.


